V. DISCUSSION ITEMS

A. NY Farmland Finder Website.

Serena presented the Farmland Finder website, maintained in partnership with the American Farmland Trust (AFT) and the NYS Department of Agriculture and Markets, to connect farms and farmers. She added this discussion item to make Committee members aware for their own use, but also to get the word out that this resource is available - particularly for farms in transition. Easement staff would be available if someone needed assistance creating a profile.

John asked if the Agricultural and Economic Viability Programs were aware of this resource. Serena said that she was uncertain, but it was a discussion item she planned to bring up in a meeting with senior leadership later in the day. She also noted that she attends quarterly meetings with AFT staff, so she encouraged Committee members to reach out if they have any questions or thoughts that could be brought to those meetings.

B. January EC

The January Committee meeting landed on the New Years holiday. Not seeing any suitable alternative dates/times at the beginning of the month, and considering that the February packet deadline is January 21st, she proposed canceling the meeting and asked if there were

any objections (there we none).

VI. STEWARDSHIP MOTIONS

A. Stoop, Mark & Nancy (PID# 6046-00): Final Subdivision Approval

Mike presented this motion. He explained that the Committee preliminarily approved a subdivision request from the landowners, Mark & Nancy Stoop, in October. Following approval, a survey was performed in November by Wakin Land Surveying (Mike was on-site to mark the approximate corners of the Acceptable Development Area (ADA)) and the landowners have finalized the deed language with their attorney for the conveyance of the subdivided parcel to their daughter.

Mike noted that there were a couple of minor changes made to the final survey included in the packet materials:

- 1. Updated acreages for the Resource Protection Area (RPA) and Farm Area (FA);
- 2. Removal of GPS waypoint locations of the approximate corners of the ADA that Mike identified in the field.

Motion to grant final approval for the revised subdivision request submitted by Mark & Nancy Stoop as described in the Easement Program Staff memo and the Stoop Subdivision Plan dated September 10, 2024. The landowner has provided the Easement Committee with a metes and bounds survey, prepared by a licensed professional surveyor at the landowner's sole expense, in order to obtain a final approval of the subdivision. Prior to the actual deed conveyance of the property, the Stoop's shall submit the proposed deed for WAC Easement Program Staff to review and approve.
